- 15 Service Class shares commenced operations in May 2000. Service Class shares carry a 0.25% annual Rule 12b-1 fee. Service Class share performance includes the performance of the series' Initial Class shares for periods prior to the inception of Service Class shares (blended performance). These blended performance figures have not been adjusted to take into account differences in the class-specific operating expenses (such as Rule 12b-1 fees). Because operating expenses of Service Class shares are higher than those of Initial class shares, the blended Service Class share performance is higher than it would have been had the Service Class shares been offered for the entire period.
- 16 Stocks of medium-sized companies may be subject to more abrupt or erratic price movements than stocks of larger companies. There are special risk considerations associated with international investing related to market, currency, economic, political and other factors.
- 17 The Fund is subject to the risk of rising and falling stock prices. In recent years, the U.S. Stock market has experienced substantial price volatility.
- 18 Stocks of small- or medium-sized companies often trade less frequently and in limited volume, and their prices may fluctuate more than stocks of larger companies. Some of these companies are more likely to have limited product lines, markets or financial resources, or to depend on a small, inexperienced management group than larger companies.
- 19 The portfolio invests in equity securities of small U.S. companies, including start-up companies. The portfolio may also invest in emerging-growth companies. Investing in start-up and other small companies may expose the portfolio to increased market, liquidity and information risks. Small companies and emerging-growth companies are often involved in *special situations*. - 24 Small-cap stocks are often more volatile and less liquid than the stocks of larger companies. Small companies may have a shorter history of operations than larger companies and may have a less diversified product line, making them more susceptible to market pressure.
- 25 Foreign risk is the risk of investments in issuers located in foreign countries. Because the Portfolio invests in foreign securities, it is subject to this risk. Investments in foreign securities may experience more rapid and extreme changes in value than investments in securities of U.S. companies. This is because the securities markets of many foreign countries are relatively small, with a limited number of companies representing a small number of industries. - 27 The returns shown for Service Shares for periods prior to their inception (Dec. 31, 1999) are derived from the historical performance of the Institutional Shares, adjusted to reflect the higher operating expenses of Service Shares.
- 28 Performance information for Class IB shares for periods prior to April 30, 1998 are based on the performance of the fund's Class IA shares adjusted to reflect the fees paid by Class IB shares, including a Rule 12b-1 fee of 0.25%. As a result, a single security's increase or decrease in value may have a greater impact on a portfolio's NAV and total return.
- 34 The returns shown for Service Shares for periods prior to their inception (Jan. 1, 2000) are derived from the historical performance of the Institutional Shares, adjusted to reflect the higher operating expenses of Service Shares.
- 35 This fund has a higher concentration of investments in the Utilities sector and may be subject to a higher degree of market risk than a fund whose investments are more diversified.

- 36 The Trustees of Putnam Variable Trust currently limit 12b-1 fee payments on Class IB Shares to 0.25% of average net assets.
- 37 Investments in the health sciences industries, even though representing interests in different companies within these industries, may be affected by common economic forces and other factors. This increases the Fund's vulnerability to factors affecting a single group of industries. This risk is significantly greater than for a fund that invests in a broader range of industries, and may result in greater losses and volatility.
